NOTIFICATION

Whereas, in pursuance of the recommendation of the Academic Committee in its meeting held on 26/11/2021 vide Item No 2, amendments have been made to Examination facilities to be extended to the students with disabilities at Higher Secondary Level as per the Right to Persons with Disability Act. 2016. As per amendment, student with disabilities can avail the following facilities –

- i) Blind, physically handicapped, dyslexic, autistic, spastic, mentally retarded and candidate with disabilities as defined in The Right of Persons with Disabilities Act, 2016 certified by competent authority will be allowed amanuensis or additional time 20 minutes per hour for each subject of examination or both as the case may be.
- ii) Hearing Impaired candidates are allowed 20 minutes per hour for each subject of Examination but no amanuensis.
- iii) The amanuensis will be of X standard or below for writing the answer to be dictated by the physically challenged candidate for H S First Year Examination. Similarly, the amanuensis will be of XI standard or below for writing the answer to be dictated by the physically challenged candidate for H S Final Year Examination. The amanuensis will be decided by the Officer-in-charge of the Examination Centre.
- iv) The candidates defined at (i) and (ii) above are exempted from Second and Third language course. They may opt either English or MIL as core subject. Further, in place of that language subject, they will have to opt an additional elective subject. Thus, candidate under the above category will have five elective subjects instead of four.
